| What is the overall deductible ? | \$2,800 individual / \$5,600 family for In-Network | Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . |
| Are there services covered before you meet your deductible ? | Yes. Preventive care is covered before you meet your deductible | This plan covers some items and services even if you haven't yet met the deductible amount, but a copay or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . | Are there other deductibles for specific services? | No. | You don't have to meet deductibles for specific services. |
| What is the out-of-pocket limit for this plan ? | \$4,000 individual / \$8,000 family for In-Network | The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met. |
| What is not included in the out-of-pocket limit ? | Premiums , balance-billing charges, amounts over usual, reasonable & customary (UCR) , and health care this plan does not cover. | Even though you pay these expenses, they don't count toward the out-of-pocket limit . |
| Will you pay less if you use a network provider ? | Not Applicable. | This plan does not use a provider network . You can receive covered services from any provider . |
| Do you need a referral to see a specialist ? | No. You don't need a referral to see a specialist . | You can see the specialist you choose without permission from this plan . |

Does this plan provide Minimum Essential Coverage? **Yes**
